All Saints' Cemetery

is a place of tranquility, peace, and natural beauty in the midst of our midtown urban setting. It is a sacred space for the burial of the ash remains of All Saints'

parishioners and their families. The names of the deceased, with the dates of birth and death, are listed on an individual cast bronze nameplate on a bronze plaque mounted on the wall of the church building.

The cemetery is located along the north wall of the church, and is overseen by the Buildings and Grounds Committee and the rector. ✝

Interment

- The ashes shall be those of a member of All Saints', former member, or a member of his or her family. Others may be buried at the discretion of the rector.
- The ashes shall be buried in biodegradable containers, or poured directly into the earth.
- Plots shall be assigned by the parish, and the location of occupied or reserved plots shall be shown on a plan which shall be kept in the church office. Plots will be numbered from 1 to 352. To the extent practicable, the committee will attempt to accommodate the wishes of those who have paid the applicable fee to arrange for interment of the remains of family members in contiguous plots.
- It is anticipated that the cemetery will be available for interment of the remains of qualifying individuals in perpetuity and that the need may arise for burial of the remains of more than 352 persons in the All Saints' Cemetery. In such event, remains will be reverently interred in previously used plots.

- The name of each person whose ashes are interred in the cemetery, with the dates of birth and death, will be listed on an individual cast bronze nameplate on a bronze plaque mounted on the wall of the church building. This plaque, with nameplates in order of interment, shall be the only marker or memorial in the cemetery.
- There will be no floral arrangements or other decorations within the cemetery, unless approved by the rector.
- A fee of \$1,000 will be charged for the burial. Full payment at the time of application is preferred; however, applications will be accepted upon receipt of a down payment of \$100, with the balance of the payment being due within one year. In the event of a change of mind, one-half of the fee or down payment, as the case may be, will be refunded. Application may be made to the rector for financial assistance as necessary.
- Receipts from burial fees will be held in a separate fund to be expended solely for the perpetual maintenance and care of the cemetery and garden, capital expenditures required in connection with the operation of the cemetery, and care of the surrounding garden area.
- The vestry and wardens of All Saints' Episcopal Church specifically reserve the right to modify, amend, or revoke these regulations from time to time.

How to Apply

- Arrangements for the interment of ash remains, either your own or those of a member of your family, may be made by filling out and signing an application available from the church office. A check made payable to All Saints' Church for the burial fee should accompany the application. This fee covers interment, purchase of a nameplate, and care of the cemetery.
- An acceptance of the application will be issued from the rector's office and will constitute a contract between the applicant and All Saints' Church.
- The original contract will be kept in a permanent file in the rector's office of All Saints' Church. A copy of the acceptance will be given to the applicant.
